

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
DHURAKIJ PUNDIT UNIVERSITY, THAILAND  
AND  
GLA UNIVERSITY, INDIA**

Dhurakij Pundit University (DPU), Thailand and GLA University, India wish to establish relations between the two institutions, and agree to cooperate with each other as follows:

**Scope of the Cooperation**

Subject to mutual consent, the areas of cooperation will include any program offered at either institution as thought desirable, feasible and of mutual benefit in fostering a collaborative relationship between the two institutions through such activities as:

- a. Exchange of students, and faculty and/or staff members
- b. Joint research activities and publications
- c. Participation in seminars and academic meetings
- d. Exchange of academic materials and other information
- e. Special short-term and other academic programs
- f. Professional development and training workshops for social work, education and human service sectors
- g. Quality assurance / accreditation programs
- h. Promoting the brand of both institutions
- i. Networking and connectivity

The terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Each institution shall designate a liaison officer to develop and coordinate the specific activities and programs agreed upon.

**Renewal, Termination and Amendment**

This Memorandum of Understanding shall remain in force for four years from the date of the final signature and is subject to renewal or termination with a six-month written notification by either party, and shall be effective on completion of the in-session semester, unless mutually agreed upon otherwise. The Memorandum of Understanding may be amended between the two parties in writing as an addendum to this agreement.


